RE: Fiscal Watch under S.C. Code Ann. § 59-20-90 (Supp. 2018)

Dear Dr. Witherspoon, Ms. Harris, and Ms. Matthews-Hazel:

On October 27, 2022, Richland County School District One (District) was given the audit report along with the findings and recommendations for the P-Card audit conducted by the South Carolina Department of Education (SCDE). The findings listed in the audit report identify numerous significant deficiencies and material weaknesses that could potentially have a significant effect on the financial condition of the district. As a result of the findings of this audit, this letter represents the official declaration of fiscal watch for the District by the SCDE pursuant to Section 59-20-90(C)(1)(a)(v).

The District has sixty days from the date of the declaration to send a recovery plan to the SCDE outlining the corrections taken to correct the issues that led to the declaration. When the recovery plan is received, the SCDE will, within thirty days, either approve or deny the recovery plan. If denied, the District will have to submit to the SCDE an updated recovery plan. While the District is under fiscal watch, the SCDE will provide technical assistance. A district under a declaration of fiscal watch must not be released from fiscal watch in the same fiscal year in which the declaration was made, but may be released the following year if the SCDE determines that the corrective actions have been or are being successfully implemented per Section 59-20-90(C)(4).

The District board of trustees may appeal a declaration of a fiscal watch to the State Board of Education (SBE) within ten calendar days after the declaration and the SBE must hold a hearing on the appeal within thirty days after the filing of the appeal or at the next regularly scheduled

SBE meeting, whichever is later. However, the District must continue to work with the SCDE when a fiscal watch is declared pending determination of the appeal per Section 59-20-90(C)(5).
